International Maritime Conventions

International Maritime Conventions Glossary

AIS (Automatic Identification System)

- Related Terms: Vessel Traffic Service (VTS), International Maritime Organization (IMO)
- Explanation: AIS is a tracking system used on ships and by vessel traffic services to identify and locate vessels. It transmits information such as vessel identity, position, course, and speed to other ships and shore stations to improve maritime safety and security.

Ballast Water Management Convention (BWMC)

- Related Terms: Ballast water, Invasive species
- Explanation: BWMC is an international treaty adopted by the IMO to prevent the spread of harmful aquatic organisms and pathogens in ships' ballast water. It requires ships to manage their ballast water to minimize the transfer of invasive species.

Collision Regulations (COLREGs)

- Related Terms: Navigation rules, International Regulations for Preventing Collisions at Sea (1972)
- Explanation: COLREGs are a set of rules established by the IMO to prevent collisions between vessels at sea. They define the actions and responsibilities of ship operators to ensure safe navigation and avoid accidents.

Detention of Ships

- Related Terms: Port State Control (PSC), Flag State, Detention order
- Explanation: Detention of ships occurs when a port state authority prohibits a vessel from leaving port due to non-compliance with international maritime conventions or regulations. It is a measure to ensure maritime safety and environmental protection.

ECDIS (Electronic Chart Display and Information System)
