Leadership and Innovation in Longevity Sciences

Adaptive Leadership – A leadership approach that encourages flexibility and rapid response to evolving scientific data and market conditions in longevity research. Lifecycle Management – Oversight of a product from conception through decline, ensuring continuous value delivery. Related terms: Product Stewardship, Post-Market Surveillance. Example: Monitoring real-world effectiveness of an approved senolytic and iterating formulation based on feedback. Practical application: Planning next-generation versions with improved dosing schedules. Challenge: Maintaining relevance as scientific understanding of aging evolves.

Supply Chain Resilience – Ability of the procurement and logistics network to withstand disruptions while delivering critical inputs for longevity product manufacturing. Systems Thinking – Holistic approach that
