Trade Mark Law And Registration

Absolute Grounds refers to the reasons that can lead to the refusal of a trade mark application, these grounds include the lack of distinctiveness, descriptiveness, and the presence of a similar mark that is already registered, the applicant must ensure that the mark does not fall under any of these grounds to proceed with the application.

Acquiescence is the process of the owner of a trade mark application or registration not taking any actions against a third party who has been using a similar mark for a period of time, this can lead to the third party gaining rights to the mark.

Action for Passing Off is a common law remedy that is available to the owner of a trade mark who has not registered the mark, it is used to prevent another party from using a similar mark that is likely to cause confusion among consumers.

Administrative Trademark Law Tribunal is a body that is responsible for hearing and deciding on trade mark disputes, it provides a faster and more cost-effective way of resolving disputes compared to the courts.
